Croad Vineyards & Winery

Martin and Patti Croad purchased their lovely 38-acre property in the Willow Creek district in January 2004, a few days after the December 2003 earthquake. Mainly undeveloped, the previous owner lived in a trailer and had planted several acres of Zinfandel, which was untended and extremely distressed when the Croads took over.

Without any intention of getting into the wine business, the Croads made friends with local grow-



ers, and began to rehabilitate the vineyard. Their first two-ton crop of Zin, made at Hank Donatoni's facility, was rated 90 points by Robert Parker, and they caught the winemaking bug! They started planting in 2005 and there are now 20 acres of Zinfandel, Grenache,

Syrah, Mourvedre and Petite Sirah.



The winery was built in 2007. The Croad's award winning wines are fruity and intense, with all of their estate grapes dry-farmed and low-yielding, and they source Sauvignon Blanc and Cabernet Sauvignon from nearby Templeton Gap vineyards.

Martin continues to run an electrical contracting business in Bakersfield, and commutes there several days each week. Patti works in the tasting room and office, and oversees the Bed and Breakfast, which opened in 2012. The Inn at Croad Vineyards attracts visitors from all over the world. They both work hands-on in the winery, producing 2,500 cases, including single varietals of their estate fruit along with three GSM blends, all named with Maori terms from their original New Zealand home.

With a minimalist winemaking philosophy, they prefer to let the vineyard express

itself, augmenting flavors with spicy French and Hungarian oak, and allowing three years of barrel age to achieve soft, structured tannins. They have no plans to expand (as if they are not busy enough!) and really enjoy the Paso Robles lifestyle.

Message to Grape Growers

The past four years of drought and the large amounts of poor quality water has had a devastating impact on some of the older vineyards. I am seeing some now that will not come back, others with normal rainfall and not only for one year may take a couple years to recover. With the increase cost of labor and chemical etc. and now the water issue and the possibility of a very expensive water district. This is not a recipe for the survival of a grape grower.

The winery's and growers need to have a better understanding of each other's needs; growers will not survive with the current prices for wine grapes. An example at 3000 dollars per ton the wine in a bottle is 4.30, glass, corks, capsules, labels and wood for aging 3.50 = 7.80 per bottle and then sold for fifteen to eighty dollars a bottle and some even more.

This may vary some from winery to winery.

Some years back when Paso Robles was the Almond capital of the world and was all dry farmed, and when the valley started planting Almond growers here could not survive with their low price and production so as a result weather than continue to lose money they let the orchard die. If this were to happen to Paso Robles grape industry and wine tasters coming to the area and see vineyards abandoned it will not be pleasant sight. The economic impact to the area no doubt would be questionable.

This is something no one wants to see so the margins need to be considered.



Let's Cook

Variations on a theme

Almost everyone I know loves Artichoke Dip! Here's the basic recipe, then suggestions of what do you do if you don't have artichokes

Preheat oven to 350 F. Using the basic Artichoke Dip receipe

- I cup Parmesan cheese, freshly grated can be a mix of cheeses, e.g., Monterey jack, Colby, etc
- I cup mayonnaise
- 4 large cloves garlic, smashed, peeled, and finely minced [to taste]
- I can artichoke hearts drained & chopped

Make your mix



Here you can either do the Artichoke version using chopped artichoke hearts or leave out the artichokes and make up what ever you want to put in, chopped chicken or sausage or chopped shrimp, chopped poblano peppers, chopped spinach, onions — or don't add anything beyond the cheese, mayo, garlic and cheese. One day I had leftover corned beef & sauerkraut, use your imagination—several years back I won a cooking contest using chopped black olives instead of the artichokes.

- Once the mix is ready, either bake it for 30 mins & serve.
- Or slice up a baguette, spread some mix on each piece, put on a cookie sheet & bake 10 mins



- Or, On a flat surface, lay out a line of won ton wrappers Add I teaspoon of filling to the middle, then draw up opposite corners to meet and form a package
- Drop each into a mini-muffin tin drawing the sides up an pinch to make a 'flower'. Bake 10 minutes
- Lay out flour tortillas and put a big scoop of mix on each tortilla & spread it out over ½ the tortilla, then carefully start rolling from the filling end jelly roll style to the end this will 'push' the filling forward so there's mix all over inside Then cut each rolled tortilla in half, bring them side-by-side and start slicing of ¼-to-1/2" slices should yield about 10 slices per roll Place slices in a min-muffin tin or side by side-by-side so the loose edges touch [so they don't unwind during cooking] Bake at 350 for 10 minutes
